Instructions:

Prior to making an application, a proponent is required to pre-consult with North Perth staff to determine the appropriateness of the request and review submission requirements. Each application must be accompanied by the application fees in the form of either cash or cheques payable to the Municipality of North Perth and the County of Perth.

If the applicant is not the owner of the subject land, a written statement by the owner which authorizes the applicant/agent to act on behalf of the owner as it relates to the subject application must accompany the application (See Section 8.0).

Additional information and studies may be required by the Municipality to evaluate the proposal. The type and scope of studies that are required will be determined through the pre-consultation process with the North Perth and Perth County planning departments. If the required additional information is not provided, the application cannot be deemed to be complete and will not be processed.

In accordance with the Clean Water Act, 2006, a number of Source Protection Plans have been developed that apply within the various watersheds within Perth County. The policies of these Source Protection Plans may affect this Planning Act application. More information about the applicable Source Protection Plans is available at:
