

Municipality of North Perth Development Charges Pamphlet

By-law No. 78-2019

This pamphlet summarizes the Municipality of North Perth policy with respect to development charges (DCs). By-law No. 78-2019 imposes Municipal-wide and areaspecific development charges for municipal services.

The information contained within is intended only as a guide. Interested parties should review the approved by-law and consult with municipal staff to determine the charges that may apply to specific development proposals.

Background

The Council for the Municipality of North Perth enacted a new development charges By-law 78-2019 effective September 1, 2019. This by-law imposes a charge on all lands developed within the Municipality of North Perth except for those exemptions as provided under the *Development*

Charge Act, 1997 and those outlined in the Bylaw 78-2019.

Purpose of Development Charges

Development charges are collected by the Municipality for the purpose of financing the construction of new capital infrastructure, as a result of the growth stemming from land development in the Municipality of North Perth.

Indexing and Phase-In of Development Charges

The development charges may be indexed annually commencing January 1, 2020 without amendment to the by-law, in accordance with the prescribed index in the Act and are being phased-in over a 3-year period commencing on January 1, 2020.

Municipal-Wide Services Included

Municipal-wide DCs have been imposed for the following categories of service in order to pay for the increased capital costs required as a result of increased needs for servicing arising from development:

- Library Services;
- Indoor Recreation Services;
- Outdoor Recreation Services;
- Child Care Services;
- Administration Services
- Fire Protection Services;
- Police Services;
- Public Works; and
- Roads and Related.

Area-Specific Services Included

Area-specific DCs have been imposed for the following services in the following areas:

- Stormwater Services (Listowel South East Drainage Area);
- Water Services (Listowel, Atwood, Wallace Ward, and wherever service is available);
- Wastewater Services (Listowel, Atwood, and wherever service is available; and
- North East Master Plan Area Engineering Services (Roads and Stormwater).

Treasurer's Statement

The Treasurer for the Municipality of North Perth shall present before Council each year a financial statement relating to the development charges by-law and its reserve funds. The statement must include for each reserve fund, a description of the service, opening and closing balances, details of any credit transactions, details of any borrowing from the reserve fund that may have occurred, the amount spent on growth related projects, the portion of each project that is funded from the reserve fund and the portion funded from other sources of financing.

This pamphlet was updated September 4, 2019 to reflect rates effective September 1, 2019.

Timing and Calculation of Payment

A development charge shall be calculated and payable in full on the date a building permit is issued. A building permit will not be issued until all development charges have been paid. Payment of a development charge may be deferred subject to terms and conditions set out by Municipal policy.

Exemptions & Incentives

DCs are payable on all new residential and nonresidential development unless the By-law or the *Act* provides an exemption. Exemptions provided in the By-law and/or the *Act* include:

- The municipality, Corporation of the County of Perth or a local board thereof;
- A board of education:
- A place or worship; or
- Public hospitals.

Entry level residential units will be charged 25% of the Municipal-wide development charges. Commercial developments up to 2,500 square feet will be charged at 50% of the applicable charge for water and wastewater services. 
Schedule 1

Map of Urban Service Area for Listowel and Surrounding Area





Map of Urban Service Area for Atwood



Map of Urban Service Area for Gowanstown




Schedule 4 Map of Urban Service Area for Molesworth
