

**NOTICE
OF THE PASSING OF A ZONING BY-LAW BY
THE MUNICIPALITY OF NORTH PERTH**



TAKE NOTICE that the Council of The Municipality of North Perth passed By-law No. **102-2025** on the **20th** day of **October, 2025**, under Section 34 of the *Planning Act, R.S.O. 1990, as amended* (herein after called the “Act”). Council considered all written and oral submissions received on this application, the effect of which helped Council to make an informed decision.

AND TAKE NOTICE that an appeal to the Ontario Land Tribunal in respect to all or part of this Zoning By-law Amendment may be made by filing a notice of appeal with the Clerk of the Municipality of North Perth either electronically via the Ontario Land Tribunal(OLT) e-file service (first-time users will need to register for a My Ontario Account) at <https://olt.gov.on.ca/e-file-service> or by mail, no later than 4:30 p.m. on **November 11th, 2025**. The filing of an appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day. The appeal must set out the objection to the By-law, the reasons in support of the objection and must be accompanied by the appeal fee required by the OLT. The appeal fee can be paid online through e-file or by certified cheque/money order to the Minister of Finance, Province of Ontario. Additional information and forms can be found on the OLT website www.olt.gov.on.ca.

PLEASE NOTE notwithstanding the above, subsection 34(19) of the Act identifies the eligible ‘persons’ that may appeal the decision to the Ontario Land Tribunal.

NO PERSON OR PUBLIC BODY shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting, or written submissions to the council, or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

AN EXPLANATION of the purpose and effect of the By-law, and a description of the lands to which the By-law applies, is attached. The complete By-law is available for inspection in the Clerk’s Office during regular office hours.

BY-LAW NO. 102-2025

EXPLANATORY NOTE

By-law No. 102-2025 of the Corporation of the Municipality of North Perth is an amendment to the Municipality of North Perth Zoning By-law No. 6-ZB-1999 and affects lands in the Municipality of North Perth legally described as Part Lot 21, Plan 194, Listowel Ward, Municipality of North Perth.

By-law No. 102-2025 rezones the subject lands or limit the accessory dwelling unit height, reduced rear yard, reduced interior side yard and reduced landscaped open space. The zoning on this land shall be shown as “R4-30” on Key Map 35 of Schedule “A” to the By-law.

Schedule "A" to the attached By-law No. 102-2025 is a map showing the location and zoning of the subject lands.

AREA AFFECTED BY THIS BY-LAW



The lands shall remain in the "Residential Zone Four (R4)" of the Municipality of North Perth Zoning By-law, By-law No. 6-ZB-1999 as amended and shall be subject to the provisions of Section 10.10.30 (R4-30). Notwithstanding the permitted uses outlined in Section 10 to the contrary. The "R4-30" zone shall permit two additional dwelling units with a reduced rear yard for a single-story dwelling to 1.4 metres (4'9"); reduced landscaped open space of 28% and reduced interior side yard of 0.6 m (2 ft).
