Public input on applications is invited. Pursuant to Section 45 of the *Planning Act*, the Committee of Adjustment for the Municipality of North Perth invites you to consider applications for minor variance and/or to forward written comments prior to the hearing.

**LOCATION OF PROPERTY:** Plan 44M81 Pt Blk 4 RP;44R6162 parts 3 and 4 (29 Malcolm Cres., Listowel)

**PURPOSE OF APPLICATION:** The purpose of the application for minor variance is to request relief from Section 10.7.6 b) of the North Perth Zoning By-law to reduce the minimum rear yard depth from 7.5 m to 4.3 m; relief from Section 5.18 to reduce the minimum parking requirements from 7 units to 6 units and relief from Section 5.1.3 (i) to permit an accessory residential structure (retaining wall) 0.47 metres (1.54 feet) from the rear yard where the by-law requires 1.2 metres (3.9 feet). The proposed variance will facilitate the construction of a stacked Fourplex.

**PUBLIC HEARING:** You are entitled to participate in this public hearing to express your views about this application or you may be represented by counsel for that purpose. If you are aware of any person interested in or affected by this application who has not received a copy of this notice you are requested to inform that person of this hearing.



If a person or public body does not participate in this public hearing to the North Perth Committee of Adjustment before the Decision is made, the person or public body is not entitled to appeal the decision of the North Perth Committee of Adjustment to the Ontario Land Tribunal.
