

**PURPOSE OF APPLICATION:** The subject application is proposing relief from Section 6.3.3.2 of the North Perth Zoning By-law to reduce the minimum exterior side yard width from 15 m to 9.87 m to facilitate the construction of a 1-storey, 56.14 m<sup>2</sup> addition to the existing single detached dwelling on the subject lands.
